

PROMOTION RULES

- 1.** Participation in the Resorts World Las Vegas Sportsbook "Can't Lose" Promotion ("Promotion") is open exclusively to newly enrolled Genting Rewards members who have no prior sports betting history at the Resorts World Las Vegas Sportsbook ("Participants").
- 2.** Participants are subject to all terms and conditions of Genting Rewards membership, as outlined in the official Genting Rewards program rules.
- 3.** Participants must be at least 21 years of age and present a valid, government-issued identification upon request.
- 4.** The Promotion will take place at Monday football games and other game dates as designated by Resorts World Las Vegas, beginning at 12:00 a.m. on Monday, September 30, 2024, and concluding at 11:59 p.m. on Thursday, December 26, 2024 (the "Promotional Period").
- 5.** The Promotion is applicable only to the first qualifying bet placed by Participants following their enrollment in both the Genting Rewards program and the Resorts World Las Vegas app and RWLV Sports Betting app.
- 6.** To qualify for participation, Participants must be a first-time sports bettor and must place a \$50 wager at the Resorts World Las Vegas Sportsbook on either the Monday football game or other game dates as designated by Resorts World Las Vegas, corresponding to the respective day of the wager.
- 7.** The initial \$50 bet must be placed within seven (7) days of the Participant's enrollment in the Genting Rewards program and the Resorts World Las Vegas app and RWLV Sports Betting app.
- 8.** In the event that the Participant's first \$50 wager results in a loss, the Participant will receive a \$50 bet reimbursement.

GENERAL RULES

- 10.** Team Members and/or relatives of Resorts World Las Vegas, its subsidiaries and advertising agencies or representatives are ineligible to participate in the Tournament.
