

12 DAYS OF HOLIDAYS PROMOTION RULES

12 DAYS OF HOLIDAYS PROMOTION GENERAL RULES

- 1. Participation in the Genting Rewards 12 Days of Holidays Promotion ("Promotion") is open to Genting Rewards members who qualify through casino play at Resorts World Las Vegas (the "Participants").
- 2. The Promotion will be held at Resorts World Las Vegas starting at 12:00 a.m. on Sunday, December 15, 2024, and concluding at 11:59 p.m. on Thursday, December 26, 2024 (the "Promotion Period").
- 3. The Promotion consists of four distinct parts:
 - a. Merry Mystery Free Play Days ("Promotion #1")
 - b. Santa's RapidFire Slot Tournament ("Promotion #2")
 - c. Blizzard of Tickets ("Promotion #3")

Part 1: MERRY MYSTERY FREE PLAY DAYS RULES

- 1. Participation in the Genting Rewards Merry Mystery Free Play Days ("Promotion #1") is open to Genting Rewards members who are enrolled in the 12 Days of Holidays Promotion.
- 2. Promotion #1 will take place at Resorts World Las Vegas from 12:00 a.m. to 11:59 p.m. on the following days in December: Sunday, December 15; Wednesday, December 18; Saturday, December 21; Tuesday, December 24; and Thursday, December 26, 2024 (the "Promotional Dates").
- 3. Participants can unlock a Mystery Free Play Bonus for every 1,500 Genting Base Points earned (excluding slot point earning boosts) on the Promotional Dates.
- 4. Each Mystery Free Play Bonus will be awarded as a system-generated random Free Play prize, with amounts ranging from a \$5 minimum to a \$200 maximum.

Part 2: SANTA'S RAPIDFIRE SLOT TOURNAMENT RULES

1. Participation in Santa's RapidFire Slot Tournament ("Promotion #2") is open to Genting Rewards members enrolled in the 12 Days of Holidays Promotion.



- 2. Promotion #2 will take place at Resorts World Las Vegas from 12:00 a.m. to 9:00 p.m. on the following days in December: Monday, December 16; Thursday, December 19; and Sunday, December 22, 2024 (the "Promotional Dates").
- 3. Participants may earn entries into the tournament according to the Earning Rules.
- 4. Each entry is valid for one (1) tournament session. Entries may also be awarded at Management's discretion.
- 5. Tournament play will occur on designated True-Time Tournament-enabled slot machines, marked with visible identifiers.

- 4. Any entries not redeemed by the end of the Tournament Play period will be void.

Part 3: BLIZZARD OF TICKETS RULES

- 1. Participation in the Blizzard of Tickets ("Promotion #3") is open to Genting Rewards members enrolled in the 12 Days of Holidays Promotion.
- 2. Promotion #3 will take place at Resorts World Las Vegas from 12:00 a.m. to 11:59 p.m. on the following days in December: Tuesday, December 17; Friday, December 20; Monday, December 23; and Wednesday, December 25, 2024 (the "Promotional Dates").
