



## RAPIDFIRE BRACKET BLAST SLOT TOURNAMENT & DRAWING RULES

### TOURNAMENT RULES

1. Participation in the RapidFire Bracket Blast Slot Tournament (“Promotion”) is open to Genting Rewards Members who earn entry through casino play at Resorts World Las Vegas (“Participants”).
2. The Promotion will be conducted at Resorts World Las Vegas during the following periods (“Promotion Period”): from 12:00 a.m. on Thursday, March 27, 2025, through 9:00 p.m. on Sunday, March 30, 2025 (“Promotion Period #1”), and from 12:00 a.m. on Saturday, April 5, 2025, through 9:00 p.m. on Monday, April 7, 2025 (“Promotion Period #2”).
3. Participants may earn Tournament entries in accordance with the applicable earning rules.
4. Each Tournament entry is valid for one (1) Tournament session. Tournament entries may also be awarded at the discretion of Management.
5. Tournament Play will take place on True-Time Tournament enabled slot machines on the casino floor. Enabled Machines will be marked by a physical identifier visibly displayed on the slot machine. Machines may notify Resorts World Las Vegas Staff upon malfunction. In the event a malfunction cannot be corrected, the Participant may be re-issued a Tournament entry to play his/her round. In the event, the Participant is unable to play an additional round, the Participant may be accommodated at Management's Discretion. A complete round must be played on a single machine.
6. A Participant's score is determined by the number of points registered on his/her assigned Machine at the end of their round, regardless of what the credit meter reads.
7. If two (2) or more Participants have the same score total from their highest round score in a Tournament, the tied Participants will equally split the sum total of the applicable prizes. For example, if three (3) Participants tie for 2<sup>nd</sup> place, they would equally split the 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place prizes; the next highest score would receive the 5<sup>th</sup> place prize amount.
8. Rankings will be scored from highest to lowest. Participant’s highest score will be used for Ranking.
9. Participants will only be awarded one (1) Free Play Prize per Promotional day.
10. Free Play Prizes awarded through this promotion will be credited directly to the Participant’s Genting Rewards account no later than 10:30 a.m. on the day following the conclusion of each Tournament.
11. All Free Play prizes must be redeemed within thirty (30) days from the date of distribution. Unredeemed prizes will expire and will not be reissued.
12. Any prize won will be awarded to the primary registered Participant. Prizes are non-exchangeable, non-transferable, and cannot be redeemed for cash or substituted for any other prizes.

### EARNING RULES

14. The Earning Period will take place each day from 12:00 a.m. to 8:30 p.m. during the Promotion Period.
15. Tournament Play will take place each day from 12:00 a.m. to 9:00 p.m. during the Promotion Period.
16. Participants may receive one (1) Tournament entry for every 500 Genting Base Points earned daily at Resorts World Las Vegas during the Earning Periods.
17. A maximum of ten (10) Tournament entries may be earned per Promotional Day.
18. Any earned Tournament entries that have not been redeemed and played by the end of each Tournament Play period will be voided and will no longer be available for play.



19. It is the responsibility of each Participant to insert their Genting Rewards card at, or after, 12:00 a.m. on each day of the Earning Period and remove their Genting Rewards card before the end of each daily Earning Period, for the session points from their initial and final sessions of play to be included in the Earning Period. Resorts World Las Vegas' Player Management systems track the official time for this Promotion and any session that begins before or ends after the Earning Period will result in all points during each session(s) being voided and of no effect.

## **DRAWING RULES**

20. Participation in the RapidFire Bracket Blast Drawing ("Drawing") is open exclusively to individuals who are active Genting Rewards members and have qualified by earning a Tournament entry into the RapidFire Bracket Blast Slot Tournament (the "Participants").
21. Participants shall receive one (1) Drawing entry for each day that they participate in the RapidFire Bracket Blast Slot Tournament.
22. A maximum of seven (7) Drawing entries may be earned per Participant during the Promotion Period.
23. The Drawing will take place on Tuesday, April 8, 2025, at 10:30 a.m.
24. A total of three (3) winners will be selected at random from all eligible Drawing entries received in accordance with these Official Rules. The winner(s) will be selected through a random, computer-generated process.
25. Winners will be notified via the email and/or phone number associated with their Genting Rewards account no later than Wednesday, April 9, 2025. Winners must confirm acceptance of their prize within twenty-four (24) hours of notification. Failure to confirm within the specified time frame will result in forfeiture of the prize.
26. If a winner forfeits their prize, an alternate winner will be selected through an additional drawing, and this process shall continue until all prizes are awarded and confirmed.
